**Declaration of "Who I Am in YHWH's Kingdom"**  
as well as "My Declaration of Expatriation"  
and "Revocation of My Signature Rescinding all known and unknown adhesion contracts"

I, Philip Royd Brown, declare the following to be true, accurate, and complete to the best of My understanding and belief.

The King of kings and The Lord of lords (Rev 19:16) commands us to "Come out of her My People, least you partake of her sins and receive of her plagues." (Rev 18:4)  
The King of kings has made a way through the United States of America:

- for His People to Come out (Expatriate) from the venue and jurisdiction of the kingdoms of this world and any de facto government and come into The Kingdom Of YHWH.
- for the kingdoms of this world to acknowledge that His People have Come out.

The united states of America Congress has made a way to expatriate. Confirmed by 15 Statutes at Large chapter 249, passed by the united states of America Congress on July 27<sup>th</sup>, 1868, which says in part:

"Whereas the right of expatriation is a natural and inherent right of all people, indispensable to the enjoyment of the rights of life, liberty, and the pursuit of happiness;..."

"Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That any declaration, instruction, opinion, order, or decision of any officer of this government which denies, restricts, impairs, or questions the right of expatriation, is hereby declared inconsistent with the fundamental principles of this government..."

I, Philip Royd Brown, do hereby Declare My expatriation from the De facto government for the United States of America and/or the United States, and from the De facto governments for any of the States. I do this for the purpose of clarifying that: if I was ever a part thereof, or if anyone ever thought I was a part thereof, they now know that I am NOT a part thereof, henceforth no one has any basis for Misrepresentation of The Truth. I am out of any and all kingdoms of this world.

Declaration of Who I am in YHWH's Kingdom

I also Declare all previous Declarations, Affidavits... concerning My Allegiance, Citizenship, Venue, Jurisdiction, or anything related thereto; made by Me in My Name - "Philip Royd Brown" - or in any "Non de guerre" (war name) purported to be My Name - made by any other or by Me - to be null and void nun pro tunc (as it should have been since the beginning).

I also Declare that I pledge My complete allegiance to YHWH, Our Holy, Heavenly, Almighty Father, to His Dear Son Yahshua The Messiah, - My Savior, My Way to The Father, and My King - and to Their Kingdom and Their Righteousness. I am an Ambassador for YHWH's Kingdom (2 Corinthians 5:20). Hence I have entered into the exclusive Allegiance, Citizenship, Venue, and Jurisdiction of the Kingdom of YHWH and of His Son Yahshua The Messiah as a Fellow-Citizen Of The Saints Of The Household of YHWH. (Ephesians 2:19)

THEREFORE, Mr. President, in The Name Of Yahshua The Messiah (erroneously referred to by many as The Lord Jesus Christ), and by The Blood Of Yahshua The Messiah, order all government agencies/entities within your jurisdiction to completely expunge any and all mention of any other than "Philip Royd Brown" that is intended to refer to Me, from your/their records - past, present, planned, or ever to be planned. I make known to you any "non de guerre" (war name) purported to be My Name, (such as PHILIP ROYD BROWN, PHILIP R. BROWN, or any other abbreviations or combinations thereof) for the sole purpose of facilitating your expungement of said name(s) from your data base records; And I do not grant you or any government agency/entity any jurisdictional claim over said previous names, but rather by the herein Expatriation and Revocation of My Signature, I hereby remove forever any jurisdictional claim you had, or ever thought you might have had, over Me through said previous names; Any name other than "Philip Royd Brown" that is intended to refer to Me, is henceforth to be considered as never existing.

My full Name "Philip Royd Brown" is in the jurisdiction and dominion of another Kingdom. Therefore, in The Name Of Yahshua The Messiah, and by The Blood Of Yahshua The Messiah, order all government agencies/entities within your jurisdiction to Change all references within your/their records - past, present, planned, or ever to be planned, concerning My Name, "Philip Royd Brown", from being considered to have allegiance, citizenship, residency, venue, or jurisdiction in the United States, State of Washington, State of Oregon, or any other State, to being considered as having Allegiance, Citizenship, Venue and Jurisdiction exclusively as a Fellow-Citizen Of the Saints Of The Household Of YHWH;

And I do not grant you or any government agency/entity any jurisdictional claim over My full Name, My body, house, papers, or effects, but rather by the herein Expatriation and Revocation of My Signature, I herein remove forever any jurisdictional claims you had, or thought you had, over Me or YHWH's Creation that I am steward of, or ever will be steward of.

My Lord, Master, and King is a jealous God, and He doesn't want to share with anyone else His 100% total Jurisdiction over Me - which I have knowingly, voluntarily, and joyfully given and committed unto Him forever - nor do I want to be shared with anyone else, including but not limited to, any and all so-called "new world order" organizations or alliances that you are in, or may be in, or may ever be in, even if you do not know, or ever will know of your involvement therein.

Declaration of Who I am in YHWH's Kingdom

The following ten questions are used to clarify Who I am in YHWH's Kingdom;

1. Who is My Sovereign? (Who does My Head say is God?)  
Yahweh, through His Son Yahshua is my *only* Sovereign.
2. To whom is My Allegiance? (Who does my heart say is God?)

6. What Position (function, calling) do I have in My Country?  
My Position, as being a Child of Him, I owe obedience to Him as the Apple of His Eye. My calling is to be a servant to Him - a Worshipper - a Composer of Music - a Singer. I have the desire and ambition to exercise the gifts that My Father hath given unto me.
7. What Jurisdiction am I in? (What Laws do I declare to be subject to?)  
As Yahweh is my Father, I am also under His Jurisdiction. I am also subject to his Laws, and I willingly accept His Laws and His Jurisdiction!
8. What Responsibilities do I have as a result of the above?  
Knowing that I am a Son of My Heavenly Father, I must be found obedient to the Work of My Heavenly Father. I am to be a light on the hill and to be responsible to the calling that He has given Me. Yahweh's desire and goal is to fully establish His Kingdom here on Earth (Daniel 2:34-35, and 44-45), and that is also My desire and goal. (\*only associated with previous never-existing name) and all similar color-of-law "rewards" (called privileges by some) concocted for Me in an attempt to seduce Me from My unalienable God-given Responsibilities and enabling Rights - Life, Liberty, and Property;

Judging from the scope of the attempted usurpation so far, I am certain that the above list is not at all inclusive, but I am equally certain that this declaration covers all worldly "rewards", past, present, planned, or those yet to be ever planned for Me without My knowledgeable written consent;
