AGREEMENT BETWEEN THE CITY OF STEVENSON AND SKAMANIA COUNTY

This agreement made and entered into this day of June, 2000, by and between the CITY OF STEVENSON, a municipal corporation of the State of Washington, hereinafter sometimes referred to as "the City," and SKAMANIA COUNTY, a legal subdivision of the State of Washington, hereinafter sometimes referred to as "the County."

RECITALS

This Agreement is entered into pursuant to the laws of the State of Washington, including the Interlocal Cooperation Act, Title 34, Chapter 39 of the Revised Code of Washington, and each of the parties hereto represents that it has authority to execute the same.

- 1. Skamania County, through its Sheriff's Department, provides law enforcement and associated criminal justice services as well as crime prevention and victim assistance programs.

 The City of Stevenson contracts with Skamania County of law enforcement services.
- The State of Washington, under Criminal Justice Funding Program Areas 1 and 4, is requiring local jurisdictions to endeavor to coordinate and contract with existing community service providers, where appropriate, to implement innovative law enforcement strategies.
- 3. The City is interested in supporting the continuation of and enhancement of services provided by the Skamania County Sheriff's Department and, as a result, applied to the State of Washington and received notice of funding as follows:
 - A. Approximately \$262.00 under Program Area I has been allocated to the Skamania County Sheriff's Department to fund training and acquisition of supplies and equipment for the drug and alcohol programs in the schools.
 - B. Approximately \$1,745.00 for Program Area 4 has been allocated to the Skamania County Sheriff's Department to supplement funding for basic criminal law enforcement services within the City of Stevenson.
- 4. The parties hereto and the public will benefit from an agreement detailing our mutual obligations and commitments with respect to the allocation of Criminal Justice Funding under Program Areas I and 4.

NOW, THEREFORE, the City and County, having considered the matters set forth above, and for and in consideration of the mutual benefits to be derived by them, agree as follows:

1. City Obligations

- A. The City will receive Criminal Justice distributions totaling approximately \$2,768.00 from the State of Washington and will allocate to the County 100% of the revenues received under Program Area I (approximately \$262.00) and Program Area 4 (approximately \$1,745.00) for a total distribution to Skamania County Sheriff's Department of approximately \$2,007.00. The funds for program areas 2 & 3 have been allocated to another agency.
- B. The City shall, after receipt of distributions under Program Area 1 & 4 from the State of Washington, distribute those funds to the County at the next regular City Council meeting.
- C. The City shall monitor voucher records submitted by the County and maintain such records for audit review.

CITY OF STEVENSON

2. County Obligations

- A. The County shall insure that all funds received from the City are allocated to the Sherift's Department for the purposes described in paragraphs 3A and 3B above.
- B. The County may incur expenses in advance of actual receipt of City criminal justice funding and retroactively apply payments against those expenditures provided those expenditures comply with the provisions of paragraphs 3A and 3B above.
- C. The County shall provide annual reports to the City, which will minimally contain proof of purchase for all expenses, charged against the criminal justice funds under program Area 1. In the event a charge is found to be inconsistent with the terms of this agreement, as determined by the State Auditor, the County may be required to repay such amounts. The report shall be submitted no later than April 30, 2001.
- D. The County will maintain records and furnish to the City on the same annual basis documentation of populations served, locations and descriptions of programs, or other information which allows the City to insure that Stevenson's population is receiving direct benefit from the Sheriff's Department programs.

3. Term

BOARD OF COMMISSIONERS

This contract shall be effective April 1, 2000 through March 31, 2001.
