Lot 2 of the Lenore Henderson Short Plat, recorded in Book 3 of Short Plats, Page 365, Skamania County Records.

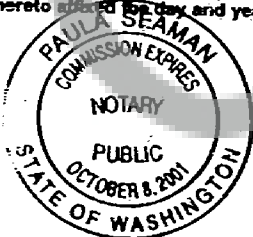
