Purpose of the Fasement: Use of the Easement Area: The purpose of the Easement is to allow pedestrian access only over an existing roadway, entering along the north boundary of the Southeast quarter of the Northeast quarter of S12, T3N, R7½E of the W.M., and accessing land along and to the east and north shoreline of the Wind River for peaceful enjoyment and noncommercial fishing by Ellen Hocker, and her successors or assigns, including their tenants and guests.
- Limitations:
 - Access to the dedicated area by motorized vehicles and horses shall be specifically prohibited from this dedication.
 - b. Cutting, digging, or the removal of any part of the natural landscape or any clearing or grading of the easement area shall be specifically prohibited from this dedication.
 - c. This Easement is granted solely for the use of the owners and occupants of the single family residence situated upon the "benefitting property," solely for pedestrian access to the Wind River for the purposes described herein.
