**WHEREAS** the Board of County Commissioners have determined that the public would be benefited by the vacation of that certain right-of-way,

**BE IT THEREFORE ORDERED BY THE BOARD OF COUNTY  
COMMISSIONERS OF SKAMANIA COUNTY WASHINGTON**, in accordance with  
R.C.W. 36.87.060, that **MARTIN ROAD (No. 11240)** within Section 6, Township 1 North,  
Range 5, East, W.M. be vacated at Mile Post 0.13 to Mile Post 0.19 (end).
