PARTIAL ASSIGNMENT OF EASEMENT

WHEREAS, by Easement, dated August 18, 1969, recorded in Skamania County, Washington land records in Volume 61 of Deeds, page 155, the State of Washington conveyed to Weyerhaeuser Company, a Washington corporation, an easement to construct, reconstruct, maintain and use certain roads (the "Road Easements") over and across property described on the attached Exhibit A;

WHEREAS, Weyerhaeuser Company, by Warranty Deed dated November 17, 2000, recorded in said Skamania County land records in Book 205, page 557, conveyed to PacifiCorp, an Oregon corporation, certain property accessed by portions of the Road Easements located in Section 22 and Section 28, Township 7 North, Range 5 East;

WHEREAS, Weyerhaeuser Company, by Partial Assignment of Easement dated November 17, 2000, recorded in said Skamania County land records in Book 205, page 564, under Auditor's File No. 140015, granted to PacifiCorp a partial assignment of the Road Easements for access to the property granted to PacifiCorp in said Warranty Deed, EXCEPT such access rights as are convenient and/or necessary for access to Weyerhaeuser Company's reserved mineral interests, which access rights have been retained by Weyerhaeuser Company;

WHEREAS, PacifiCorp, by Special Warranty Deed dated JAV. 16⁴⁴, 2001, recorded in said Skamania County land records in Book 205, page 434, under Auditor's File No. 147 conveyed to Public Utility District No. 1 of Cowlitz County, a municipal corporation of the State of Washington ("Cowlitz PUD"), the following described property:

NOW, THEREFORE, PacifiCorp, an Oregon corporation, hereby assigns, sets over and transfers unto Public Utility District No. 1 of Cowlitz County, a municipal corporation of the State of Washington, those rights under said Partial Assignment of Easement providing access to and from said Cowlitz PUD lands.
