DEED OF TRUST

THIS DEED OF TRUST, made this 30 day of January, 2001, between Jeffrey D. Jones, a married person as his sole/separate estate property, as GRANTOR, whose address is P.O. Box 189, 12101 NE 18th Street, Cascade Locks, OR 97014, and Clark County Title Company, as TRUSTEE, whose address is 1400 Main Street, Vancouver, Wa., 98660, and Margit Becker, as BENEFICIARY, whose address is 2034 SE 28th Place, Portland, Or., 97214.

Grantor hereby irrevocably grants, bargains, sells and conveys to Trustee in trust, with power of sale, the following described property in Skamania County, Washington:

Should grantor sell, convey, transfer, dispose of said property, or any part thereof, or any interest therein, without the written consent of beneficiary being first obtained, then beneficiary shall have the right, at its option, to declare all sums secured hereby immediately due and payable.

In the event of default of the obligation secured by this deed of trust, the grantor herein assigns to the Beneficiary, all of the rents generated by this property.

TOGETHER WITH all the tenements hereditaments and appurtenances, now or hereafter thereunto belonging or in anywise appertaining, and the rents, issues, and profits thereof and all other property or rights of any kind or nature whatsoever further set forth in the Master Deed of Trust hereinafter referred to, SUBJECT, HOWEVER, to the rights, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

THIS DEED IS FOR THE PURPOSE OF SECURING PERFORMANCE of each agreement of Grantor incorporated by reference or contained herein and payment of the sum Sixty Thousand and no/100 DOLLARS (\$60,000.00) with interest thereon according to the terms of a promissory note of even date herewith, payable to Beneficiary or order and made by Grantor; all renewals, modifications or extensions thereof, and also such further sums as may be advanced or loaned by Beneficiary to Grantor, or any other successors or assigns, together with interest thereon at such rate as shall be agreed upon.

By executing and delivering this Deed of Trust and the Note secured hereby, the parties agree that all provisions of Paragraphs 1 through 35 inclusive of the Master Form Deed or Trust hereinafter referred to, except such paragraphs as are specifically excluded or modified herein, are hereby incorporated herein by reference and made an integral part hereof for all purposes the same as if set forth herein at length, and the Grantor hereby makes said covenants and agrees to fully perform all of said provisions. The Master Form Deed of Trust above referred to was recorded on the twenty-fifth (25th) day of July, 1968, in the Official Records of the offices of the County Auditors of the following counties in Washington in the book, and at the page designated after the name of each county, to wit:

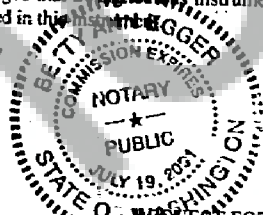

The South half of the Southwest quarter of the Northeast quarter of Section 36, Township 4 North, Range 7 1/2 East of the Willamette Meridian, in the County of Skamania, State of Washington.

TOGETHER WITH an easement 30 feet in width for ingress, egress and utilities over, under and across a strip of land situated within the North half of the Southwest quarter of the Northeast quarter of Section 36, Township 4 North, Range 7 1/2 East, Willamette Meridian, being 15 feet on each side of the following described centerline.

BEGINNING at a point lying North 01°08'05" East, 46.17 feet from the Southwest corner of said North half of the Southwest quarter of the Northeast quarter, which point is on the shoulder of Panther Creek Road; thence South 88°14'20" East, 198.72 feet to the center of an intermittent stream; thence South 82°33'35" East, 101.66 feet; thence South 63°35'49" East, 81.00 feet to a point on the South line of said North half of the Southwest quarter of the Northeast quarter (from the Southwest corner thereof lies North 88°35'49" West, 373.00 feet), and there terminating.
