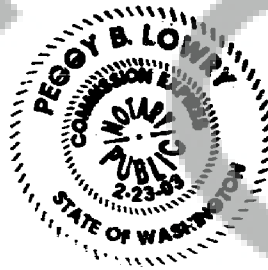

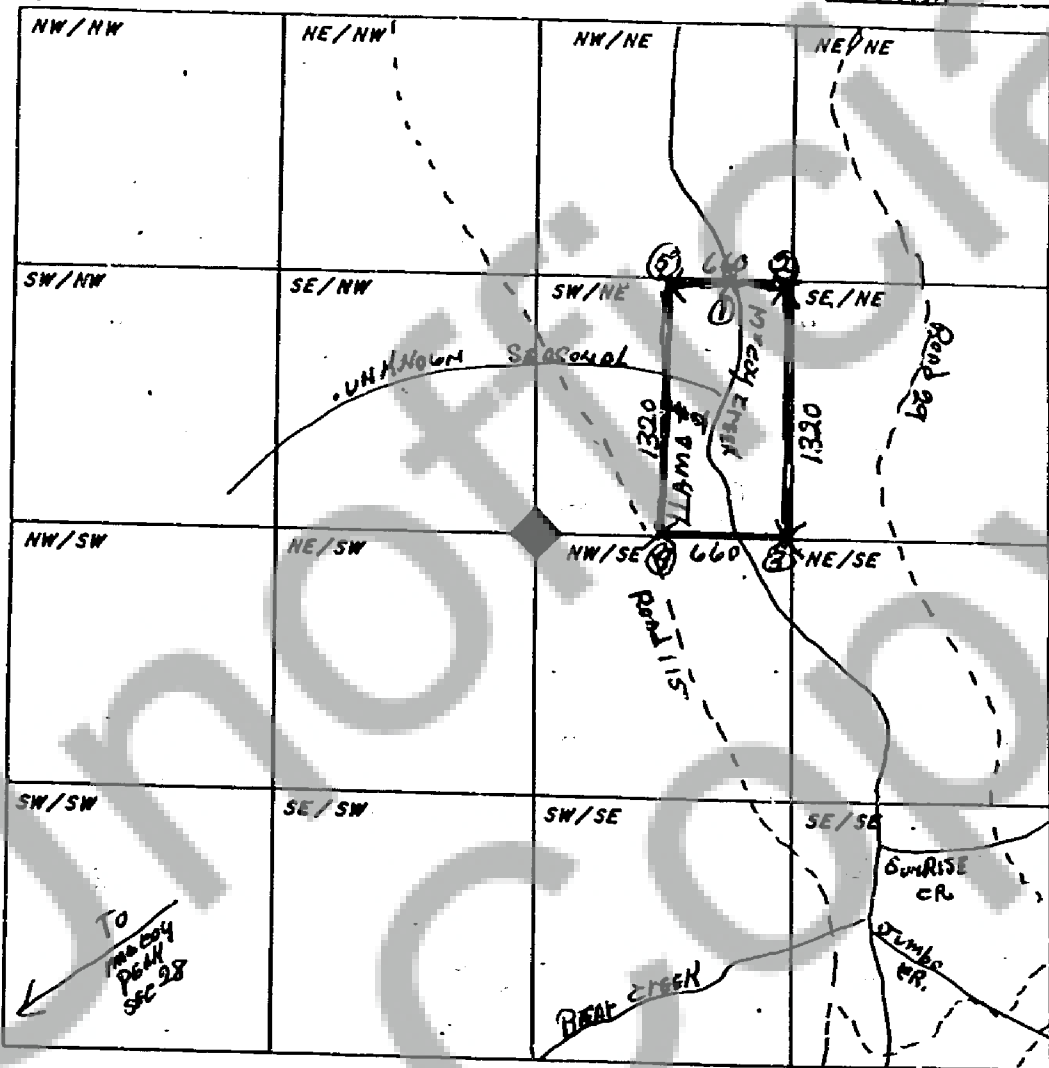

When drawing your claim(s) use an ordinary ruler. 1/8th of an inch would be 100 feet so a full size lode (600' x 1500') would be 3/4" by 1 7/8". A full size placer (1320' x 660') would be 1 5/8" by 13/16".
