Grant of Easement

Whereas, the Grantors Terry and Linda Sehy owners of the following property: LOT 1(T.L. 1400) of The Charles and Vicky Seward Short Plat in GL 2, S 29, T 3N, R8E, W.M., of Skamania County, in the State of Washington, as recorded in Book 187, Page 551 of Skamania County, Washington records.

Whereas, the Grantee Charles W. Seward has an ownership interest in the adjoining real property East of said LOT 1 in GL 2, S 29, T 3N, R8E, W.M. (T.L. 1500), which is accessed by Seward Road, an existing road. Said property is described by boundary line adjustment in Book 164, Page 68 of the Skamania County records.

Now, therefore in consideration of mutual benefit, the Grantors, do hereby grant and convey unto the Grantees, their heirs, successors and assigns, a perpetual easement 60 feet in width for the use of ingress and egress, and utilities. Said easement follows the centerline of the existing Seward Road, as recorded on above referenced Seward Short Plat and continues over and beyond to the Grantees property.


