This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between LUCKY ESSEX, as Grantor, to RIVERVIEW SERVICES, INC. as Trustee, and RIVERVIEW COMMUNITY BANK, as beneficiary, dated June 24, 1999, and recorded June 29, 1999, under Auditor's File No. 135574, records of Skamania County, Washington.
- 2. Said Deed of Trust was executed to secure, together with other undertakings, the payment of a promissory note in the sum of \$127,000.00 with interest thereon, in favor of RIVERVIEW COMMUNITY BANK and to secure any other sums of money which might become due and payable under the terms of the Deed of Trust.
- The described Deed of Trust provides that the real property conveyed therein is not used principally for agricultural or farming purposes.
- 4. Default having occurred in the obligations secured and/or covenants of the Grantors, as set forth in "Notice of Trustee's Sale" described below, which by the terms of the Deed of Trust make operative the power to sell, the thirty-day advance Notice of Default was transmitted to the Grantors, or his successor in interest, and a copy of said Notice was posted or served in accordance with law.

- RIVERVIEW COMMUNITY BANK, being then the holder of the indebtedness secured 5. by said Deed of Trust, delivered to said Trustee a written request directing said Trustee or its authorized agent to sell the described property in accordance with law and the terms of said Deed of Trust.
- The defaults specified in the "Notice of Default" not having been cured, the Trustee, in 6. compliance with the terms of said Deed of Trust, executed and on November 29, 2000, recorded in the office of the Auditor of Skamania County, Washington, a "Notice of Trustee's Sale" of said property as Auditor's File No. 139784.
