## Water Agreement

The undersigned hereby state the following: 1. That the parties have had an existing verbal water use agreement since November of 1994, which allowed the water users to have water from the provider's well for domestic use on their property. 2. The provider, Elizabeth Mapelli, owns and installed the well on her property, Lot 2 of the Mapelli-Pinnell Short Plat, in October 1994, and since that time has been providing water to the users, Sara Mapelli and Theodore Holdt. 3. The users hereby agree to pay the provider \$40.00 per month for water and power to pump the water. 4. The users hereby agree to maintain the water line to their property located on Lut 1 of the WM. Barbur Short Plat from the providers lot described above at their own expense. 5. This water usage right shall terminate when the users have their own direct water supply. 6. This water usage agreement shall terminate every three years from the date hereof; however, the parties may extend this agreement for another three years prior to each three year termination period.
