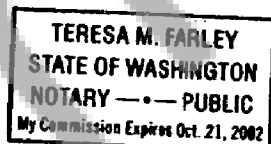
agreement in any manner or particular, and that said agreement was in all respects in full force and effect at the time of decedent's death as aforesaid.
