Lender will accept, use and retain these payments as a non-refundable loss reserve in lieu of Mortgage Insurance. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a share of the premiums yaid to the insurer, the arrangement is often termed "captive reinsurance."
