A portion of the Southeast quarter of the Northeast quarter of Section 34, Township 2 North, Range 6 East, Willamette Meridian, Skamania County, Washington described as follows:

BEGINNING at the most Northerly corner of Lot 1 of the 'Nelson Short Plat' as recorded in Book 3 of Short Plats, Page 33, Skamania County Auditor's records, said point being approximately 30 feet South of the Northwest corner of the Southeast quarter of the Northeast quarter of Section 34; thence South 40°02'50" East, along the North line of Lot 1, for a distance of 60.95 feet to the TRUE POINT OF BEGINNING; thence South 01°12'55" West, parallel with and 40 feet Easterly of the West line of Lot 1, for a distance of 61.31 feet; thence South 44°44'00" East, 494.92 feet to an inner corner of Lot 1 at a point that is South 74°32'10" West 80.00 feet from the Northeast corner of Lot 1; thence North 40°02'50" West, 539.35 feet to the TRUE POINT OF BEGINNING.

SUBJECT TO Easements and restrictions of record.

The purpose of this deed is to affect a boundary line adjustment between adjoining parcels of land owned by Grantor and Grantee; it is not intended to create a separate parcel or parcels, and is therefore exempt from the requirements of RCW 58.17 and Skamania County Short Plat Ordinance.
