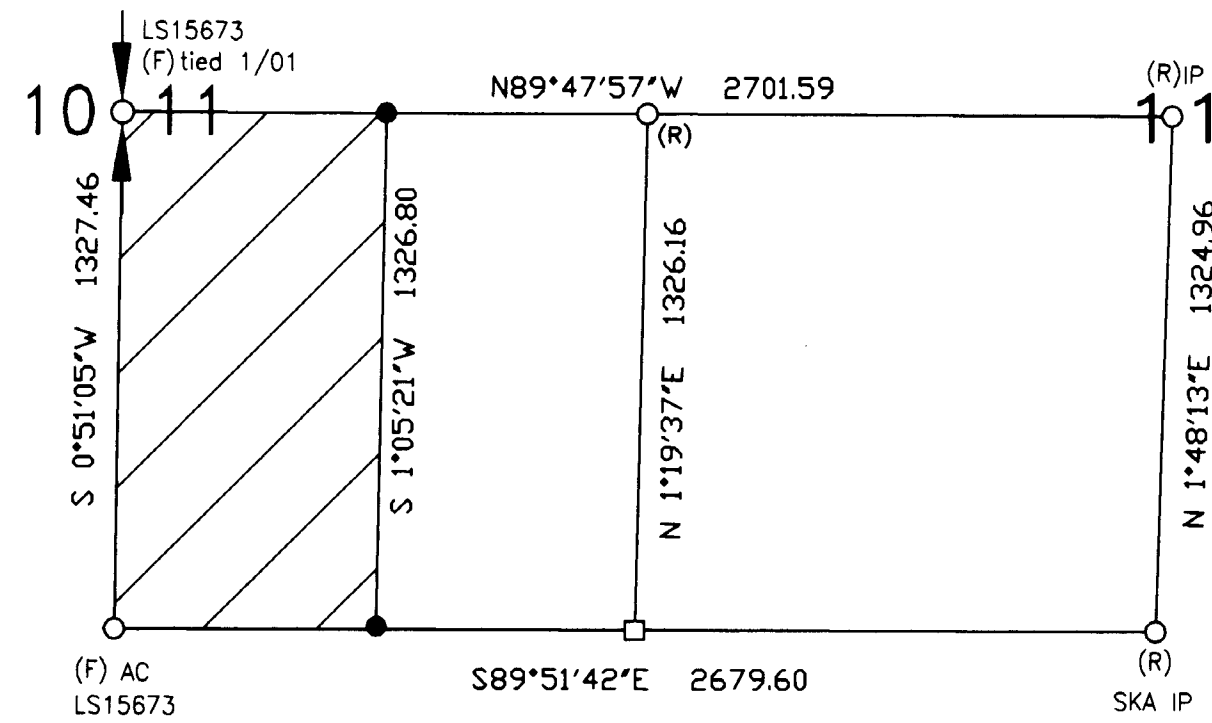

TRAVERSE STATEMENT: A closed field traverse which tied the existing monuments of the parcel shown was made with a Sokkia five-second station and related measuring equipment, all of which met State standards of WAC 332-130 at the time of this survey. Field work was conducted during the period of January 4-16, 2001, the purpose of which was to monument the new lot corners.

SURVEY NARRATIVE: Row closures of 4 second in angle and 0.05 foot were in excess of 1:10000 but balanced for mathematical closure. Minor discrepancy in some fence line locations are noted.
