

illand by you, I understand the proposed guardrail project would nictures (i.e. guardraile). Therefore, this project self-a considered "repair and maintenance." I also understand ille would be visible from one or more Key Viewing

Given these circumstances, the new guardraits would be subject to the scenic guidelines that may affect color, refinativity and other aspects of structures visible from Key Viewing Areas. Our experience at the Gorge Commission has shown that using natural metal guardrails (which rust to a dark brown, nonreflective surface) is a practical and cost effective way to meet the scenic guidelines regarding color and reflectivity.

You seem to be concerned that the new guardrails would not match existing nearby galvanized or painted guardrails. I have two thoughts. First, the scenic guidelines do not provide exceptions that address your concerns. Therefore, I believe new guardrails need to fully comply with the scenic guidelines. Second, most motorists would pass guardrails at high speeds. Therefore, the difference between existing and new guardrails might not be obvious.

I hope these thoughts are helpful.
