Hickey and Jane Doe Hickey, have not answered in this cause in any manner whatsoever, and are wholly in default, and the Court being fully advised in the premises, and the Court further finding that no just reason exists for the delaying of the entry of a judgment against said defendants, and finding that such judgment should be immediately entered against said defendants, NOW, THEREFORE,

IT IS THEREFORE ORDERED that the defendants, Steven D. Hickey and Jane Doe Hickey, be and they are hereby in default and default of said defendants is hereby entered.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED, that the plaintiff, Western Credit Services Inc. d/b/a, Washington Mutual Finance, be and it is hereby awarded judgment against the defendants, Steven D. Hickey and Jane Doe Hickey, in the sum of \$1,953.38, together with interest thereon to date of judgment in the amount of \$304.69, together with attorney fees in the amount of \$750.00, together with plaintiff's costs and disbursements in this action in the amount of \$140.20, for a total judgment of \$3,148.27. Since this judgment is founded on a written contract providing for the payment of interest until paid at a specified rate, this judgment shall bear interest at the rate of 24.9% per annum until paid.
