AMENDMENT TO BY-LAWS
OF
SKAMANIA LANDING OWNERS ASSOCIATION, INC.
AKA/WOODARD MARINA ESTATES, INC.
STEVENSON, WASHINGTON

At the Special Meeting of the Skamania Landing Owners Association, Inc., a Washington corporation, held July 24, 2001 at Skamania, Washington. Article IX, Assessments, Section 1, was amended and adopted as follows by official action of the members:

"SECTION 1: The members of the corporation shall be liable for the payment of such charges or assessments as may from time to time be fixed and levied by the Board of Trustees pursuant to the Articles of Incorporation and these By-laws and subject to the provisions of said Articles and By-laws. The amount of such charges and assessments levied upon a member shall in no event, except as hereinafter provided, exceed in any one year the sum of Two Hundred Twenty dollars (\$220.00)

Except as modified or changed by this document, the remainder of the By-laws of the Corporation dated July 15, 1968 remains in full force and effect.
