MCKEAN, HUSBAND AND WIFE, as Grantor, to SKAMANIA TITLE, as Trustee, in favor of TIME MORTGAGE CORPORATION, as Beneficiary, the beneficial interest in which is presently held by THE CHASE MANHATTAN BANK, AS TRUSTEE OF IMC HOME EQUITY LOAN TRUST 1998-2 UNDER THE POOLING AND SERVICING AGREEMENT DATED AS OF MARCH 1, 1998.

PARCEL I

The East one-half of Lot 14 and Lot 15, MALFAIT RIVER FRONT TRACTS, as recorded in Volume "A" of Plats, at Page 123, records of Skamania County, Washington.

EXCEPT that portion of said Lot 15, described as follows:

Beginning at the intersection of the East line of said Lot 15, with the Southerly right-of-way line of Malfait Tract Road;

Thence South 02° 31' East, along the East line of said Lot 15, a distance of 95.61 feet to the True Point of Beginning;

Thence South 02° 31' East, to the Southeast corner of said Lot 15;

Thence Northwesterly along the South line of said Lot 15, to a point which bears South 06° 24' West from the True Point of Beginning;

Thence North 06° 24' East to the True Point of Beginning.
