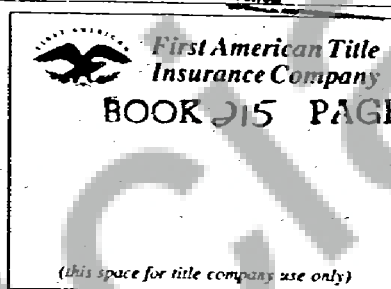

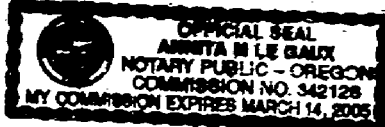

That portion of the Northeast Quarter of Section 25, Township 3 North, Range 7 East of the Willamette Meridian, in the County of Skamania, Stevenson, Washington, described as follows:

Beginning at the Northwest corner of said Northeast Quarter; thence South 88 degrees 43' 15" East along the North line of said Northeast Quarter a distance of 517.54 feet; thence South 88 degrees 43' 15" East along the North line of said Northeast Quarter a distance of 232.70 feet; thence South 13 degrees 33' 00" East a distance of 2720.56 feet more or less to the South line of said Northeast Quarter; thence North 88 degrees 49' 33" West along the South line of said Northeast Quarter a distance of 155.05 feet to the True Point of Beginning; Thence North 13 degrees 30' 00" West a distance of 1185.08 feet more or less to a point which is South a distance of 1485.00 feet from the North line of said Northeast Quarter; thence North 88 degrees 43' 15" West parallel to the North line of said Northeast Quarter a distance 976.85 feet more or less to the West line of said Northeast Quarter; thence South 00 degrees 53' 33" West a long the West line of said Northeast Quarter to a point 676.50 feet North to the Southwest corner of said Northeast Quarter, said point being the Northwest corner of a tract of land conveyed to M. Mesquers by deed recorded in Book 39, Page 271, deed records of Skamania County, Washington; thence East a long the North line of said M. Mesquers tract to the West Right-of-Way line of Kanaka Creek Road; thence Southeasterly a long said West Right-of-Way to the South line of said Northeast Quarter; thence East a long said South line to the True Point of Beginning;
