Dear Mr. and Mrs. Anderson:

The Planning Department issued a final Director's Decision on May 28, 1998 for the above referenced application. However, on December 10, 2001, the Planning Department received a letter from you requesting to change the location of your approved covered arena to the location of the old house. Also, in a telephone conversation on December 17, 2001, you requested to change the size of the arena from the approved 60' x 100' to 80' x 100'.

By changing the location of the covered arena to the location of the old house would, as you have stated in your letter, reduce the amount of excavation required, locate the arena much closer to existing utilities and would better cluster on development in one portion of the subject property. All of these help your development even better meet the goals of the National Scenic Area. As for the increase from 60' x 100' to 80' x 100', because of the existing trees to the south and to the east of your proposed new location, the increase in size would not be visible from any key viewing areas.

Pursuant to SCC §22.06.080(B), a change or alteration to an approved action, if determined to be minor by the Director, may be "deemed consistent with the provisions of this Title and the findings and conclusions on the original application." I have determined that the proposed request constitutes a minor change, therefore, the original decision shall be amended to allow the covered arena to be located in the location of the old house on your site plan as well to allow the increase from 60' x 100' to 80' x 100' of the covered arena.

All of the original conditions in the Director's Decision are still valid and shall be complied with. This amendment must be recorded with the Skamania County Auditor's office and does include a 20 day appeal period (see below).

## APPEALS




