RELINQUISHMENT OF EASEMENT RIGHTS

WHEREAS, the STATE OF WASHINGTON, DIVISION OF FORESTRY, now known as DEPARTMENT OF NATURAL RESOURCES, by easement document dated April 29, 1947, filed for record under Auditor's No. 36682, Skamania County Auditor's office, was granted a nonexclusive easement over and across a tract of land as hereafter more specifically described, for the purpose of constructing and maintaining a road to provide access for forest protection purposes only, said easement having been granted by R.M. Hegewald of Stevenson, Washington, and,

WHEREAS, said easement was granted over and across the following described lands situated in Skamania County, Washington, to wit:

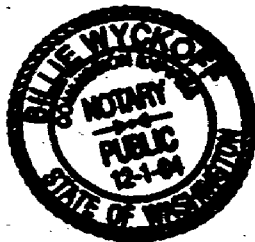
NE1/4SW1/4 of Section 35, Township 3 North, Range 7 East; Section 1, Township 2 North, Range 6 East; W1/2 Section 6, E1/2NW1/4 Section 7, SW1/4SE1/4 Section 7, all in Township 2 North, Range 7 East; and the W1/2SE1/4 Section 25, Township 3 North, Range 6 East and,

WHEREAS, said easement was for an access road for forest protection purposes and the Washington State Department of Natural Resources no longer has desire or need for such easement right, and wishes to clear encumbrances from title to real property,

NOW, THEREFORE, the Washington State Department of Natural Resources does hereby surrender and relinquish all its right, title, and interest in and to the above granted easement rights, and all such rights, duties, and liabilities as may have been incurred under said grant of easement.
