WATERLINE EASEMENT DEED

For and in consideration of good and valuable consideration, receipt whereof is hereby acknowledged, the Grantor, SKAMANIA OPCO, LLC, a Delaware limited liability company (hereinafter "Dolce"), does hereby grant, convey and warrant to the Grantee, The City of Stevenson, Washington, a Washington Municipal Corporation, ("the City"), its successors and assigns, in connection with the installation of a 12" waterline (the "Waterline"), a nonexclusive easement approximately seven hundred fifty feet (750") in length and fifteen feet (15") in width located as shown on Exhibit "A" attached hereto and by this reference incorporated herein, under, over, through and across the DOLCE property (the "servient estate"), described in Exhibit "B" attached hereto, for the use and benefit of the City for public utility purposes, including the right to access said easement for maintenance, restoration and repair of the Waterline, in perpetuity.

This Waterline Easement Deed is intended by the parties to generally locate the easement temporarily, and will be replaced by a revised Waterline Easement Deed indicating the exact location of such Waterline upon receipt of as-built surveys following construction of the Waterline; provided, however, that such revised Waterline Easement Deed shall contain the same terms and conditions act forth herein (other than the legal description of the casement granted herein).

The Waterline is being constructed and installed in accordance with the terms and WATERLINE EASEMENT DEED - Page 1

conditions of that certain Development Agreement for Waterline Construction dated ______, 2001, by and between Dolce and the City (the "Development Agreement").

Other than in connection with the initial construction and installation of the Waterline pursuant to the Development Agreement, the operation, repair, maintenance, replacement and removal of the Waterline and its related facilities, including any subsequent improvements related thereto, shall be at the sole cost and expense of the City; provided, however, that the repair and maintenance of the 8" domestic service waterline after the meter, and the fire line after the double check valve that serves the improvements located on the Dolce property and that is connected to the Waterline shall be at the sole cost and expense of Dolce (unless any such damage to Dolce's 8" waterline or fire line results for the acts or omissions of City).

It is distinctly understood and agreed that this instrument does not constitute a conveyance of the land above described nor of the mineral therein and thereunder but grants only rights-of-way and easements subject to the following:

- (a) Neither Dolce nor its successors of assigns, nor Dolce's agents, employees, representatives or contractors, shall interfere with or obstruct the use of said easement by the City, its successors or assigns, for the construction, operation, maintenance or removal of the Waterline and underground and above ground appurtenances in the servient estate, except to the limited extent permitted under paragraph (c) hereof.
- (b) This conveyance of the easement is made subject to the title encumbrances and matters affecting title to the servient estate as the date hereof, as shown in the Official Real Property Records of Skamania County, Washington, to the extent valid and subsisting as of the date hereof.
- (c) Dolce, for itself, it successors and assigns, hereby reserves and shall have WATERLINE EASEMENT DEED Page 2

the right at all times to dedicate, construct, place, maintain, protect, operate, repair, alter, substitute, replace and remove (i) roads, parking lots, streets and sidewalks upon and across the servient estate, and (ii) electric, telephone, cable television, gas and water lines, and sanitary and storm sewer drainage pipes in, upon and across the servient estate, in each case so long as such improvements do not unreasonably interfere with the City's use of the easement as herein contemplated, or otherwise violate Federal, State or local laws or regulations.






