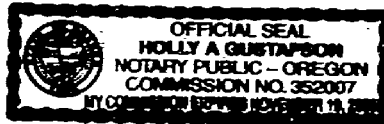


Exhibit A

COMMENCING at the intersection of the centerline of Frank-Johns Road and the Division line of the Shepard D.L.C. in the Southwest quarter of Section 36, Township 3 North, Range 7 1/2 East, of the Willamette Meridian, in the County of Skamania, State of Washington; thence South  $26^{\circ}10'33''$  East along said centerline a distance of 88 feet; thence South  $64^{\circ}04'$  West to the Center of Kanaka Creek; thence upstream along the center of said creek to its intersection with the East line of Strawberry Loop Road in Section 36, Township 3 North, Range 7 East; thence Northerly along the East line of said Strawberry Loop Road to its intersection with the said division line of the Shepard D.L.C.; thence East along said division line 330 feet, more or less, to the Point of Beginning.
