This Agreement is made this 22nd day of March, 2002, by and between U.S. Bank National Association as successor in interest to U.S. Bank ("Bank") and U.S. Bank, N.A. ("Refinancer").

Bank is the beneficiary under a deed of trust (the "Junior Deed of Trust") dated June 17, 1998, granted by Robert A Sourek Jr and Nancy E Sourek, husband and wife ("Borrower"), and recorded in the office of the County Recorder, Skamania County, Washington, on July 6, 1998, as Document Number 132094, Book 178, Page 963, encumbering the real property described therein (collectively, the "Property"). Refinancer is the beneficiary under a deed of trust (the "Senior Deed of Trust") dated MacL 23 2002, granted by the Borrower, in the same office on recorded march 29 AF144187 V2222 Pc 409 2002 as _, encumbering the property. ACCORDINGLY, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby agrees with Refinancer that the lien of the Junior Deed of Trust on the Property is and shall be and shall remain fully subordinate for all purposes to the lien of the Senior Deed of Trust on the Property, to the full extent of all sums from time to time secured by the Senior Deed of Trust; provided, however, that the total indebtedness secured by the Senior Deed of Trust does not exceed \$173,500.00, exclusive of interest thereon, amounts advanced to protect the lien and priority of the Senior Deed of Trust, and costs of collection, and provide further, that this agreement shall not be effective until each other mortgage or other tien recorded against the property (other than the Senior Mortgage) and each judgment that is a lien against the Property shall be subordinated of record of the lien of the Senior Mortgage.
