The map on page two (2) outlines the boundaries and marks the approximate location of the posted Notice of Location.

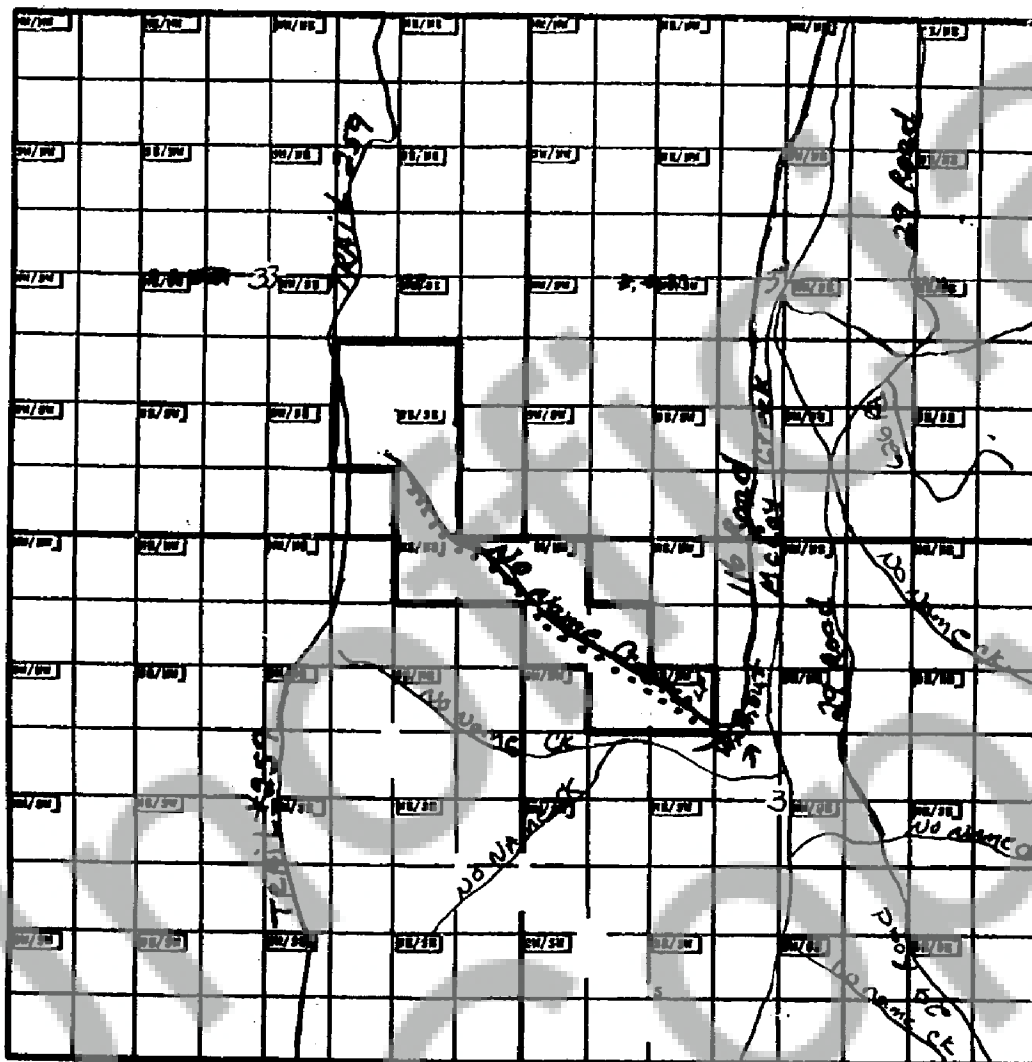

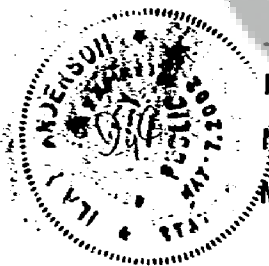
