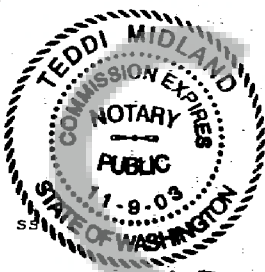

## Schedule "A"

Donald R. and Clara F. Clark

An easement to Skamania County for the construction, maintenance and use for a drainage ditch, located in the southwest quarter of the northwest quarter (SW  $\frac{1}{4}$ , NW  $\frac{1}{4}$ ) of Section 36, Township 3 North, Range 7 East, W.M., in Skamania County, Washington.

Drainage Ditch Centerline Description

Commencing at the West one quarter corner of Section 36, Township 3 North, Range 7 East, W.M., said point bearing S  $1^{\circ}18'09''$ W a distance of 2,641.50 feet from the northwest corner of said Section 36, thence N  $30^{\circ}04'26''$ W, 528.98 feet to the initial point of the easement centerline herein described, said point being Station 0+00.00; thence N  $86^{\circ}42'20''$ E, 71.46 feet to Station 0+71.46, which is the P.C. of a 1000 foot radius curve to the right; thence following said curve through a central angle of  $9^{\circ}17'45''$ , a length of 162.24 feet to P.T. Station 2+33.70, thence S  $83^{\circ}59'55''$ E, 37.59 feet to Station 2+71.29, which is the P.C. of a 100 foot radius curve to the left; thence following said curve through a central angle of  $17^{\circ}25'03''$ , a length of 30.40 feet to P.T. Station 3+01.69, thence N  $78^{\circ}35'03''$ E, 93.65 feet to Station 3+95.34, which is the P.C. of a 100 foot radius curve to the right; thence following said curve through a central angle of  $35^{\circ}23'54''$ , a length of 61.78 feet to P.T. Station 4+57.12, thence S  $66^{\circ}01'03''$ E, 30.57 feet to Station 4+87.69, which is the P.C. of a 75 foot radius curve to the right; thence following said curve through a central angle of  $30^{\circ}31'44''$ , a length of 39.96 feet to P.T. Station 5+27.65, thence S  $35^{\circ}29'19''$ E, 3.61 feet to Station 5+31.26, which is the terminus of the alignment herein described.

Right-of-Way Description

A strip of land northerly of the centerline of Ryan-Allen Road, County Road No. 20380 and easterly of the centerline of Aalvik Road, County Road No. 20710, and lying southerly and westerly of a line fifteen (15) feet northerly and parallel to the above described centerline, the sidelines being prolonged or shortened to conform with the Grantor's property lines.

Only that portion of the above-described right-of-way that falls within the grantor's real property, which is the Bonneville Power Administration Tax Exempt Parcel in the southwest quarter of the northwest quarter (SW  $\frac{1}{4}$ , NW  $\frac{1}{4}$ ) of Section 36, Township 3 North, Range 7 East, W.M., in Skamania County, Washington.

The easement area is shown by hatching on the attached diagrams and labeled "Exhibit A".
