With the understanding that Little Fir Road in Landerholm Short Plat, Skamania County, Washington, does not continue East from Landerholm Short Plat through the survey designated Beacon Highlands recorded in Book 1 of Surveys at Page 257 under Auditor's File No. 91239, recorded September 12, 1980, records of Skamania County Washington, the undersigned party(ies) to the Lewis River Properties Road Maintenance Agreement do hereby release the United States of America from the Road Maintenance Agreement, and attached as Exhibit B to the Grant of Easement, File #99496, Book 84 Page 732 and #101026, Book 100, Page 944, recorded in Skamania County on July 2, 1985;

And release the United States of America from the Beacon Highlands No. 2 (aka Landerholm Short Plat and Elmer Short Plat) and Northerly Adjacent Parcel Road Maintenance Agreement, File #115108, Book 132, page 369, recorded in Skamania County.

WHEREAS, this action is needed to facilitate the acquisition of the Hazel O. Price property by the United States of America. Property is described on attached Exhibit "A".

This Road Maintenance Agreement remains in effect for all parties other than the United States.

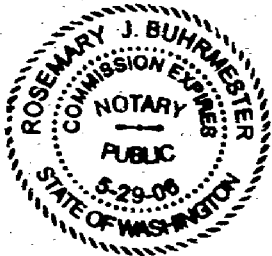
