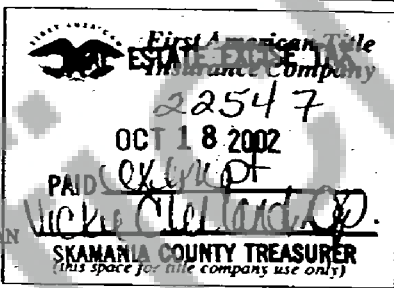
conveys and quit claims to JEFFERY C. HOLT, A MARRIED MAN


