## Exhibit A

A tract of land in the Northwest quarter of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at a point marked by a 1/2 inch iron pipe located 400 feet South of the Northwest corner of the Southeast quarter of the Northwest quarter of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, Skamania County, Washington; thence East 250 feet, more or less, to the center of the channel of the Washougal River, the line passing through a 1/2 inch iron pipe at the top and edge of the steep bank of the river; thence South-Southwesterly along the center of the channel of the Washougal River to a point on an East-West line located 150 feet South of the Point of Beginning; thence West 170 feet, more or less, through a 1 inch steel rod at the top of the bank over looking the river to a 3/4 inch iron pipe located 550 feet South of the Northwest corner of the Southeast quarter of the Northwest quarter of said Section 34, 100 feet to a 1 inch steel rod; thence North 80° West 65.5 feet, more or less, to a 1 inch steel rod located at the edge of the road; thence North-Northeasterly along the edge of the road 49 feet, more or less, to a 344 inch iron pipe located West of the Point of Beginning; thence East 40 feet, more or less, to the 1/2 inch iron pipe marking the Point of Beginning.
