## COMMUNITY PROPERTY AGREEMENT

THIS COMMUNITY PROPERTY AGREEMENT, entered into this day by and between ROBERT H. TICHENOR and LORENA S. TICHENOR, husband and wife, of Skamania County, State of Washington;

## WITNESSETH:

WHEREAS, the parties hereto are the owners of certain real and personal property situate in the State of Washington; and
