NOTICE OF REQUESTED RELINQUISHMENT OF WATER SERVICE

Please be advised that the Riverside Estates Association (REA) has petitioned Department of Ecology to relinquish the original water rights granted by Department of Ecology to serve Lots 4, 8, 10 and 12 in the Riverside Estates subdivision due to the unavailability of water. Those lots can either request REA to try and obtain water at their expense, or obtain their own system on these lots. REA has also requested Department of Ecology to establish Lot 5, 6, 7, 9, 11 and 13 as the only lots lawfully having water rights from the Riverside water system. Lot 3 does not have water rights to the Riverside Estates Association pursuant to the Department of Ecology water rights, and any such water so misappropriated shall be terminated as of June 1, 2003. The original Department of Ecology water right did not cover Riverside Lots 1, 2, 3 or 14. The lots that REA considers properly part of the system are lots 5, 6, 7, 9 11 and 13.
