DECLARATION OF COVENANT

I, STEVE KONELL, Member of SKAMANIA COVES LLC., owner in fee simple of the land described herein, hereby declare this covenant and place same on record.

SKAMANIA COVES LLC., the owner in fee simple of the following described real estate situated in Skamania County, State of Washington; to wit:

Those portions of Government Lots 2, 3 and 4 in Section 31, Township 3 North, Range 8 E.W.M., lying southerly of the Evergreen Highway, also known as State Road Number 8 as the same is now constructed and established; EXCEPTING; (1) a strip of land 100 feet in width conveyed to the Portland and Seattle Railway Company by deed dated February 2, 1906, and recorded at Page 450 of Book 1 of Deeds, Records of Skamania County, Washington; (2) the easterly 75 feet of Government Lot 4 of said Section 31, lying southerly of State Highway Number 8 as presented located and constructed (June 10, 1958) and northerly of the right of way of the Spokane, Portland and Seattle Railway Company acquired by deed dated February 2, 1906, and recorded at Page 430 of Book 1 of Deeds, Records of Skamania County, Washington. Assessor's Parcel No. 03-08-31-0-0-1200-00.

On which the Grantor owns and operates a small water system supplying water for public use located on said real estate at:

Those portions of Government Lots 2, 3 and 4 in Section 31, Township 3 North, Range 8 E.W.M., lying southerly of the Evergreen Highway, also known as State Road Number 8 as the same is now constructed and established; EXCEPTING; (1) a strip

of land 100 feet in width conveyed to the Portland and Seattle Railway Company by deed dated February 2, 1906, and recorded at Page 450 of Book 1 of Deeds, Records of Skamania County, Washington; (2) the easterly 75 feet of Government Lot 4 of said Section 31, lying southerly of State Highway Number 8 as presented located and constructed (June 10, 1958) and northerly of the right of way of the Spokane, Portland and Seattle Railway Company acquired by deed dated February 2, 1906, and recorded at Page 430 of Book 1 of Deeds, Records of Skamania County, Washington. Assessor's Parcel No. 03-08-31-0-0-1200-00.

Said water system located approximately as designated in Exhibit "A", attached hereto and incorporated herein.

Grantor is required to keep the water supplied from said well free from impurities which might be injurious to the public health.

It is the purpose of these grants and covenants to prevent certain practices hereinafter enumerated in the use of said Grantor's water supply.

NOW THEREFORE, the Grantor agrees and covenants that said Grantor, its heirs, successors and assigns will not construct, maintain, or suffer to be constructed or maintained upon the said land of the Grantor and within 100 (One Hundred) feet of the well herein described, so long as the same is operated to furnish water for public consumption, any potential source of contamination, such as septic tanks and drainfields, sewerlines, underground storage tanks, roads, railroad tracks, vehicles, structures, barns, feed stations, grazing animals, enclosures for maintaining fowl or animal manure, liquid or dry chemical storage, herbecides, insecticides, hazardous waste, or garbage of any kind or description.

PROVIDED THAT, the Department of Health recognizes that the continued use of the existing roadway identified in the sketch attached, as Exhibit "B" is a permissible use, within the intent of the recorded covenant. Department of Health further recognizes that said roadway may be maintained to its existing level without harm to the water system.

These covenants shall run with the land and shall be binding to all parties having or acquiring any right, title, or interest to the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.


