AGREEMENT AND GRANT OF EASEMENT

Grantors and Grantees desire to memorialize an agreement in regards to the above-described adjoining lots owned by them, for the benefit of each of them, and; therefore, hereby agree and Grantors grant an easement to Grantees legally described as follows:

30 FOOT ROAD EASEMENT SERVING "GLACIER POINT SHORT PLAT":

A non-exclusive easement for ingress, egress, and utilities and for the purposes of development over the West 30 feet of that portion of the Southwest quarter of Section 21, Township 7 North, Range 5 East, Willamette Meridian, Skamania County, Washington that lies North of the US Forest Service "90 Road" and South of the Northwesterly line of Lot 4 of the "Glacier View Short Plat" as recorded in Book 3 of Short Plats, page 402. Provided that the grantees shall be entitled to also use the above described easement for access to any future development that may occur on the grantee's property which lies North of Lot 4 of the "Glacier View Short Plat".

The easement created by this Agreement and Grant is superior and paramount to the rights of any of the parties to this Agreement in the respective servient state so created, and the parties further agree that it is a covenant that shall run with the land and shall be binding on and shall inure to the benefit of the parties to this Agreement and Grant of Easement, their respective heirs, successors and assigns.
