4. That the Board did on 26th day of October, 1981 set the date of 9th day of November, 1981, at 11:00A.M. at the Courthouse for a public hearing on the matter of these road vacations, and given by publication and posting as provided by law.
5. That on 9th day of November, 1981, at 11:00A.M., said public hearing was held and all statements and comments from the public were received, considered and recorded.

IT IS THEREFORE ORDERED BY THE BOARD OF COUNTY COMMISSIONERS, as follows:

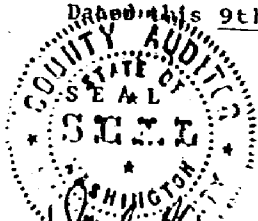
1. The County Roads or parts of County Roads as listed on attachment B of this Resolution be VACATED as of this date.
