# LIMITED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS that I, Anita R. Smith, do make, constitute and appoint Stanley D. Smith as my true and lawful attorney-in-fact for us in my name, place, and stead, for the limited purpose of selling the following real property owned jointly by us. Said property is commonly known as 621 Orchard Lane, Underwood, Washington, and is particularly described as:

That portion of the East half of the West half of the Northeast quarter of Section 15, Township 3 North, Range 10 East of the Willamette Meridian in the County of Skamania and State of Washington, more particularly described as follows:

Beginning at the Southwest corner of the East half of the West half of the Northeast quarter of said Section 15, thence North along the West line of said East half of the West half of the Northeast quarter 792 feet; thence East at right angles to said West line 165 feet to a point; thence South parallel to said West line 792 feet to a point on the South line of the said Northeast quarter which is 165 feet East of the True Point of Beginning; thence West to the True Point of Beginning.

To issue escrow instructions, enter into escrow agreements, execute satisfactions of judgment, lien releases or to perform any other act or execute any other document necessary for the transfer of said property;
