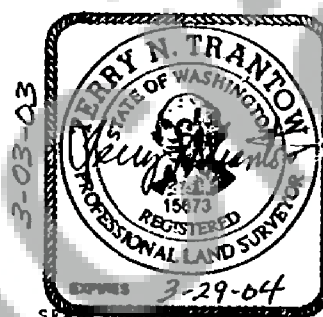

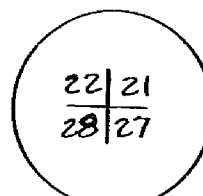
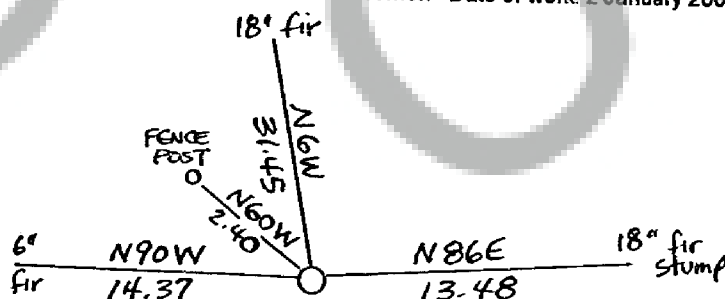
dead 48' fir, N82E, 112 links (73.92 ft.); dead 48' fir, S65E, 146 links (109.56 ft.);  
40' fir stub, S84W, 62 links (40.92 ft.); 20' fir, N45W, 281 links (185.46 ft.)

Skamania Co. IP & BC found in 1966, set by H.S. Hall, Co. Engineer

LS 9025 in 1982 found all but the Northwest bearing tree; at N45W, 185.46 ft., found depression & charred wood.

Found County IP & BC marked as shown, 2 ft. above natural ground, from which bear new witness trees:

18' fir, N06W, 31.45 feet to nail at center of tree scribed WT; 18' fir stump, N86E, 13.48 feet to nail at center of tree scribed WT; 6' fir, N90W, 14.37 feet to nail at center of tree scribed WT;  
A fence post lies N60W, 2.4 feet from the corner. Date of work: 2 January 2003
