PROJECT:

Remove the existing boathouse and portions of the existing dock and concurrently repair the dock areas that join the boathouse. A new two-slip boathouse, approximately 13.5'x 22.5', 8' in height, will be installed as replacement and a new section of dock will be added. The applicant has indicated that they will use the existing pilings that are still usable, replace old ones in bad repair, and install new ones where needed for the new extension of the boathouse and dock. The applicant is not proposing any tree removal, and the old material will be removed by putting it on a barge and taking it to the Wauna Lake Clubhouse dock and road (about 50 feet away) to haul away.

LOCATION:

Lot 11, Wauna Lake Club Road; Section 15 of T2N, Range 7E, W.M. and identified as Skamania County Tax Lot #32-07-15-0-0-1511-00.

DESCRIPTION:

Wauna Lake Club.

ZONING:

DECISION:

Based upon the entire record, including particularly the Staff Report, the application by Peggy Stamm, described above, subject to the conditions set forth in this Decision, is found to be consistent with Title 22 SCC and is hereby Approved.

Although the proposed development is approved, it may not be buildable due to inadequate soils for septic and/or lack of potable water. These issues are under the jurisdiction of Skamania County's Building Department and the Washington State Health District.

Approval of this request does not exempt the applicant or successors in interest from compliance with all other applicable local, state, and federal laws.

CONDITIONS OF APPROVAL:

The following conditions are required to ensure that the subject request is consistent with Skamania County Title 22. This document, outlining the conditions of approval, must be recorded by the applicant in the deed records of the Skamania County Auditor in order to ensure notice of the conditions of approval to successors in interest. SCC §22.06.050(C)(2).

- As per SCC §22.06.050(C)(2), this Administrative Decision SHALL BE RECORDED by the applicant in the County deed records prior to commencement of the approved project.
- 2) All developments shall be consistent with the enclosed site plans, unless modified by the following conditions of approval. If modified, the site plans shall be consistent with the conditions of approval. (See attached, Page 5-6)
- Prior to final inspection, all disturbed areas shall be re-vegetated.
- 4) All existing vegetation shall be retained, including aquatic vegetation, and maintained, in a healthy condition.
- 5) The applicant shall comply with all conditions in the Hydraulie Project approval.
- 6) The applicant shall contact the Washington Department of Fish and Wildlife to ensure that the proposed development is being constructed using best management practices, and that the proposal complies with all applicable laws.
- The following procedures shall be effected when cultural resources are discovered during construction activities:
 - a) Halt Construction. All construction activities within 100 feet of the discovered cultural resource shall cease. The cultural resources shall remain as found; further disturbance is prohibited.
 - b) Notification. The project applicant shall notify the Planning Department and the Gorge Commission within 24 hours of the discovery. If the cultural resources are prehistoric or otherwise associated with Native Americans, the project applicant shall also notify the Indian tribal governments within 24 hours.

Notice of Appeal forms are available at the Planning Department Office and must be accompanied by a \$500,00 nonrefundable filing fee.

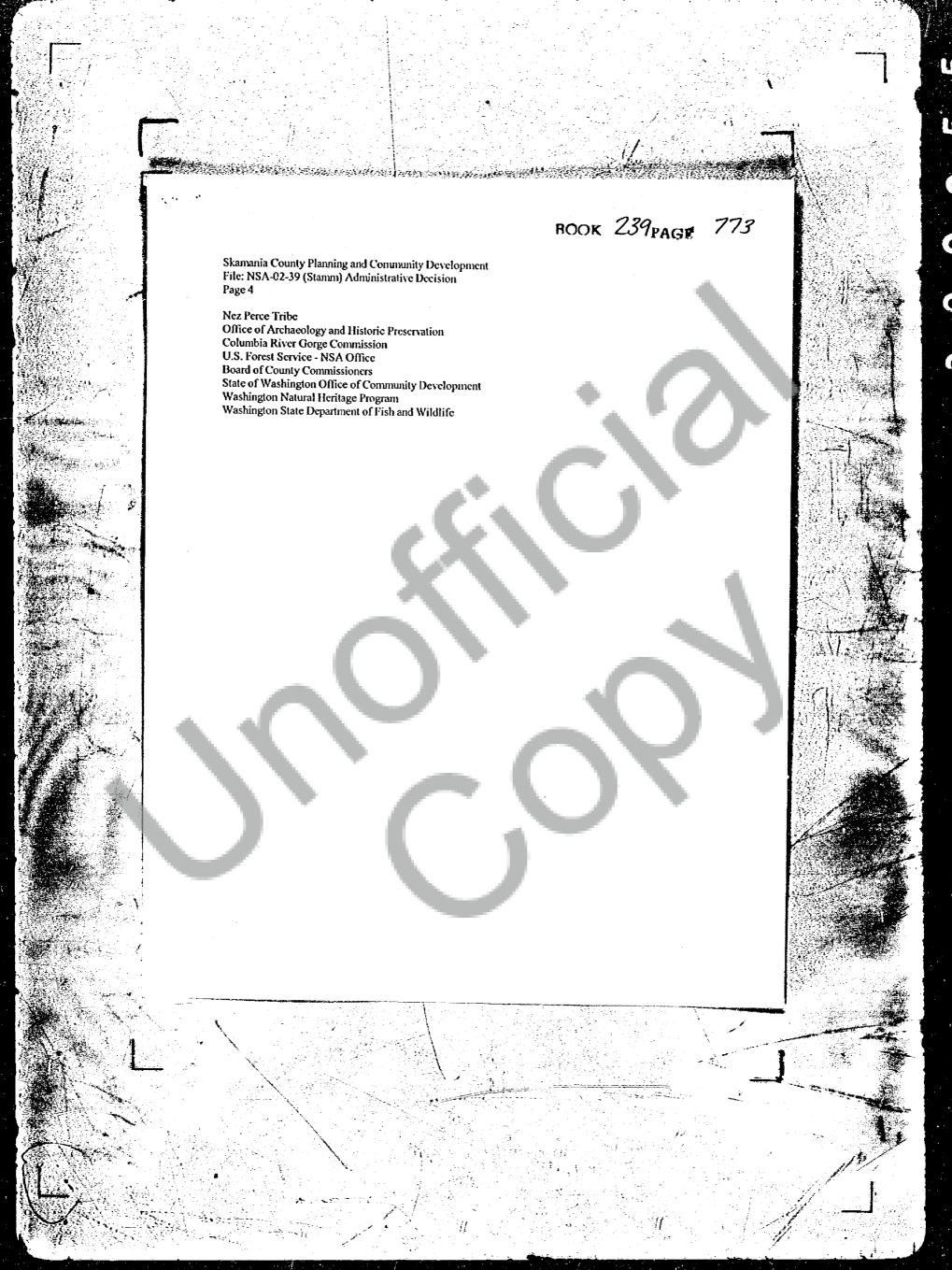
