Grant, et ux, by instrument recorded in Book 32, Page 259; thence Scuth 340 feet; thence West 437.5 feet, more or less, to the intersection with the West line by the Northeast Quarter of the Southeast Quarter of said Section 20; thence North 340 feet to the point of beginning.

EXCEPT the Northerly 200 feet thereof. ALSO EXCEPT right of way for State Highway No. 8-C.
