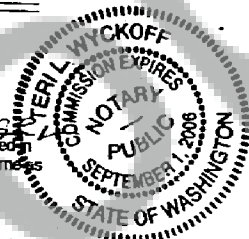

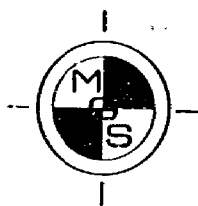

Thence South 00°51'29" East, for a distance of 952.53 feet to the TRUE POINT OF BEGINNING.

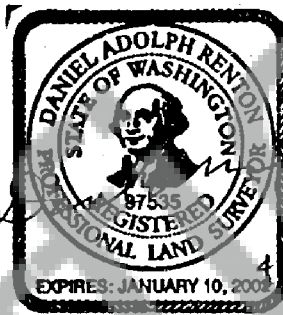

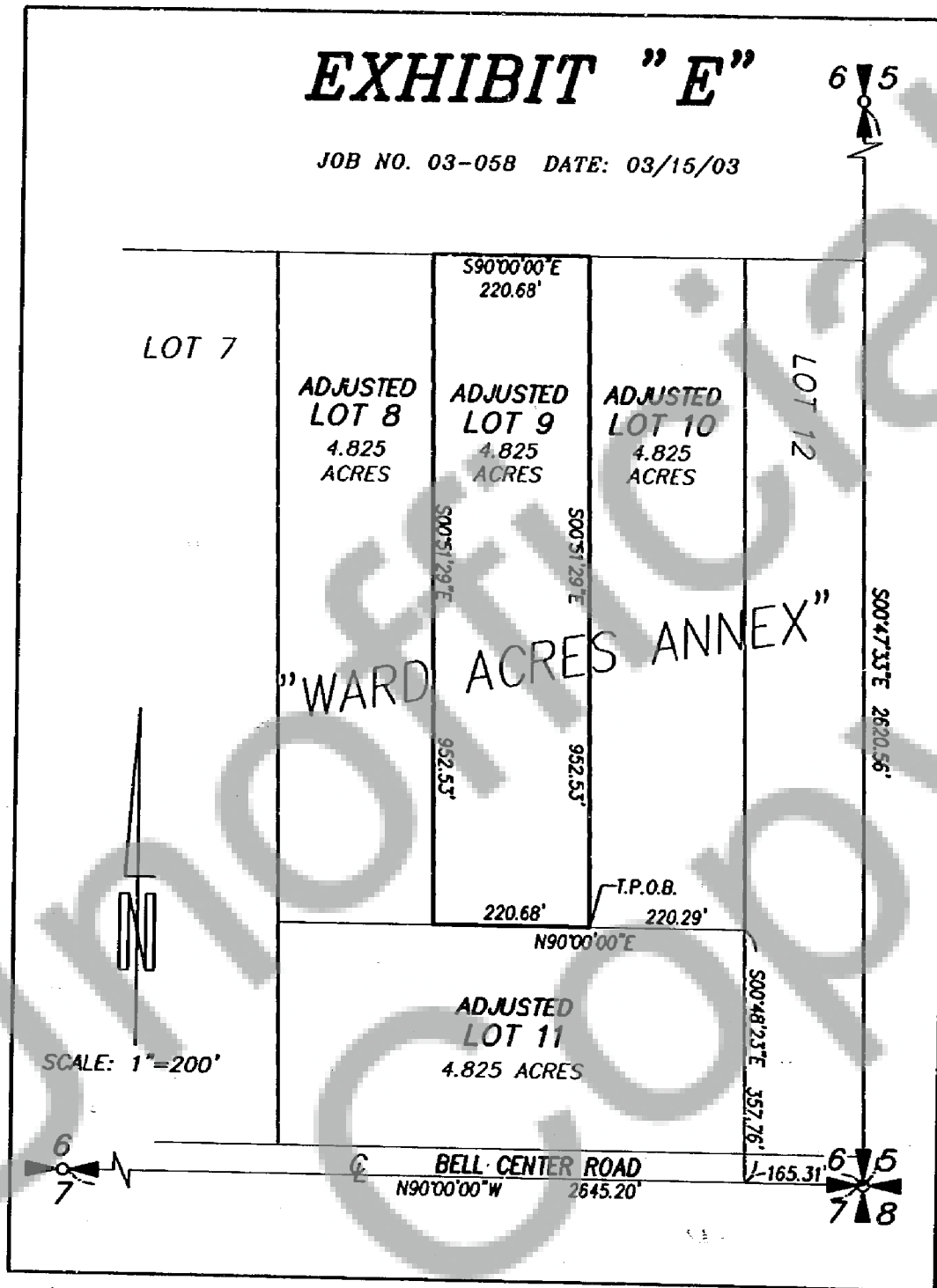
