All improvements located on the lease hold interest in the following described real property located in said Skamania County, State of Washington:

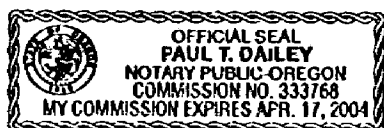
