THIS LINE OF CREDIT TRUST DEED IS DATED MAY 12, 2003 AMONG Louis P Lenczowski and Patricia L Lenczowski, whose address is 91 Bear Ridge Lane; Washougal, WA 98671 (referred to below as "Grantor"); Pacific Northwest Federal Credit Union, whose address is 12106 N.E. Marx Street, Portland, Oregon 97220 (sometimes referred to below as "Lender" and sometimes as "Beneficiary"); Clark County Title Company and whose address is 1400 Washington St., Suite 100, Vancouver, WA 98660 (referred to below as "Trustee").

This Line of Credit Trust Deed secures the Home Equity Credit Account Agreement (the "Agreement") dated May 12, 2003 in the maximum principal amount at any one time of \$20,000.00 For purposes of security, the maximum term of your Account and the Agreement is thirty (30) years, which includes the specific draw and repayment period including any renewals or extensions thereto.

1. CONVEYANCE AND GRANT. For valuable consideration, Grantor conveys to Trustee for the benefit of Lender as Beneficiary all of Grantor's right, title, and interest in and to the real property described above ("Real Property"), together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all easements, rights of way, and appurtenances; all water, water rights and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters.

2. DEFINITIONS. The following words shall have the following meanings when used in this Trust Deed:

a. Indebtselaces. The word "Indebtedness" means all principal and interest payable under the Home Equity Credit Account Agreement and any amounts advanced or expended by Lender to discharge obligations of Grantor or expenses incurred by Trustee or Lender to enforce obligations of Grantor under this Trust Deed. This Trust Deed secures your Equity Line of Credit Account or Home Equity Account under the Agreement. The term "Equity Line of Credit" is a revolving line of credit account which obligates Lender to make advances to Grantor in the maximum principal amount at any one time as set fourth above until the Agreement is terminated or suspended or if advances are made up to the maximum credit limit, and Grantor complies with the terms of the Agreement. Funds may be advanced by Credit Union, repaid by Grantor, and subsequently readvanced by Credit Union in accordance with the Agreement. Notwithstanding the amount outstanding at any particular time, this Trust Deed secures the total indebtedness under the Agreement. The "Home Equity Account" permits Borrower to request additional advances after the initial advance subject to the Credit Union's credit and security verification. The unpaid balance of your account under the Agreement will remain in full force and effect notwithstanding a zero outstanding balance on (... line from time to time. h. Personal Property. The words "Personal Property" mean all equipment, fixtures, and other articles of personal property owned by Grantor, now or hereafter attached or affixed to the Real Property; together with all accessions, parts, and additions to, all replacements of,

e. Property. The word "Property" means collectively the Real Property and the Personal Property.

d. Related Documents. The words "Related Documents" mean and include without limitation all advance vouchers, loan agreements, guaranties, security agreements, mortgages, deeds of trust, and all other documents, whether now or hereafter existing, executed in connection with Grantor's Indebtedness to Lender

3. PAYMENT AND PERFORMANCE. Grantor shall pay to Lender all amounts secured by this Trust Deed as they become due, and shall strictly perform all of Grantor's obligations under the Agreement and Trust Deed.

4. POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that its possession and use of the Property shall

be governed by the following provisions:

a. Possession and Use. Unless and until Lender takes any action under paragraph 17, Grantor may (a) remain in possession and control of the Property, and (b) operate and manage the Property. The following provisions relate to the use of the Property or to other limitations on the Property.

Duty to Malmiala. Grantor shall maintain the Property in tenantable condition and promptly perform all repairs and maintenance

necessary to preserve its value .

E. Hazardous Substances. Grantor represents and warrants that the Property never will be so long as this Trust Deed remains a lien on the Property, used for the generation, manufacture, storage, treatment, disposal, release or threatened release of any hazardous substance, as those terms are defined in the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. Section 9601, et seq. ("CERCLA"), the Superfund Amendments and Reauthorization Act ("SARA"), applicable state laws, or regulations adopted pursuant to any of the foregoing. Grantor authorizes Lender and its agents to enter upon the Real Property to make such inspections and tests as Lénder may deem appropriate to determine compliance of the Property with this paragraph. Any inspections or tests made by Lender shall be for Lender's purposes only and shall not be constitued to create any responsibility or liability on the part of Lender to Grantor or to any other person. Grantor agrees to indemnify and hold Lender harmless against any and all claims and losses resulting from a breach of this paragraph of the Trust Deed. This obligation to indemnify shall survive the payment of the Indebtedness and the satisfaction of this Trust Deed.

Nulsance, Waste. Grantor shall not cause, conduct or permit any nuisance nor commit or suffer any strip or waste on or to the Property or any portion thereof. Specifically without limitation, Grantor will not remove, or grant to any other party the right to remove, any timber, minerals (including oil and gas), soil, gravel or rock products without the prior written consent of Lender.

e. Lender's Right to Enter. Lender and its agents and representatives may enter upon the Real Property at all reasonable times to attend to Lender's interest and to inspect the Property for purposes of Grantor's compliance with the terms and conditions of this Trust

Deed.

L. Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good fa th any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and so long as Lender's interests in the Property are not jeopardized. Lender may require Grantor to post adequate security reasonably satisfactory to Lender, to protect Lender's interest.

Duty to Protect. In addition to the acts set forth above in this section, Grantor shall do all other acts that from the character and use
