COMMUNICATIONS RIGHT-OF-WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, Thomas A. Alway and Valerie J. Alway, hereinafter called grantors, for One dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, do hereby grant unto UNITED TELEPHONE COMPANY OF THE NORTHWEST, an Oregon corporation, dba Sprint, hereinafter called grantee, and to its successors and assigns, subject to valid existing easements and rights, a nonexclusive easement for an existing communications line upon the lands of the grantors situated in the County of Skamania and the State of Washington, more particularly described as follows:

A strip of land, 10 feet in total width, along the existing Mars Landing private road which is located in the SE $\frac{1}{4}$ /SE $\frac{1}{4}$ of Section 21, Township 2 North, Range 6 East, Willamette Meridian.

The location of said easement is generally depicted on the attached Exhibit "A" which by this reference is made a part hereof and is generally further described as follows:

Beginning at the Westerly edge of the Bonneville Power Administration access road (Mars Landing private road) at the intersection with the Southern section line of Section 21; thence in a Northerly direction along the Westerly edge of said road for approximately 50 feet to the intersection with the centerline of the County Road known as Mars Landing Road (formerly known as Duncan Creek Road) which is the terminus point of this easement.

The grantee shall have the right to construct, reconstruct, operate and maintain the existing communications line and associated existing facilities on or under the above described lands and to cut and trim trees and shrubbery that may interfere with or threaten to endanger the operation and maintenance of said line or system.

It is agreed that all facilities, including all communications equipment, installed on the above-described premises at the grantee's expense shall remain the property of the grantee, removable at the option of the grantee. Furthermore, it is agreed that any rights and privileges not expressly conveyed hereby remain with the grantor.

TO HAVE AND TO HOLD unto the UNITED TELEPHONE COMPANY OF THE NORTHWEST, an Oregon corporation, its successors and assigns, the easement rights hereby granted.




