- 1. To keep the property in good condition and repair, to permit no waste thereof, to complete any building, structure or improvement being builties about to be built thereon, to restore promptly any building, structure or improvement thereon which may be damaged or destroyed, and to comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting the property.
- 2. To pay before delinquent all lawful taxes and assessments upon the property to keep the property free and clear of all other charges, hence recumbrances impairing the security of this Deed of Trust.
- 3.
