Affidavit of Kurt S. Rohrbacher, President, and Ronald W. Green, Vice President, of the
Mill-A Volunteer Firefighters, for the Purpose of Filing the Legal Description of the
Mill-A Firefighters' Service Area Boundaries

THIS DECLARATION is made this 5 day of August, 2003, by KURT S.
ROHRBACHER and RONALD W. GREEN, President and Vice President, respectively, of the
Mill-A Volunteer Firefighters, on behalf of the Mill-A Volunteers, to file the legal description of the
Service Area Boundaries covered by the Mill-A Volunteer Firefighters.


WITNESSETH:

WHEREAS, the officers agree that the Mill-A Volunteers Service Area Boundaries are as
follows:

All of Township 4 North, Range 9 East, Willamette Meridian, Skamania County, except Sections 6,
7, 18, 19, 30 and 31: including that portion of Township 3 North, Range 9 East, Willamette
Meridian, Skamania County, described as follows:

True point of beginning being the Southeast corner of Section 13; thence westerly along the South
line of said Section 13 and continuing along the South line of Section 14 to the thread of the stream
of the Little White Salmon River; thence southerly along said thread to the South line of Section 23;
thence westerly along the South lines of Sections 23, 22, 21 and 20; thence North along the West line
of Sections 20, 17, 8 and 5 to the North line of said Township; thence East along the North line of
said Township to the Northeast corner of said Township; thence South along the East line of
Sections 1, 12 and 13 to the true point of beginning. A service area boundary map is attached as
part of this document.

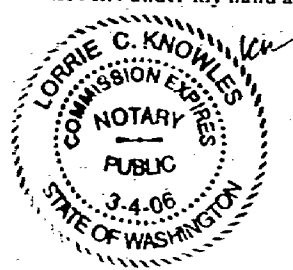
