EXHIBIT 'A'

The South Half of the Southwest Quarter of the Northeast Quarter of Section 36, Township 4 North, Range 7 ½ East of the Willamette Meridian, in the County of Skamania, State of Washington.

TOGETHER WITH an easement 30 feet in width for ingress, egress and utilities over, under and across a strip of land situated within the North Half of the Southwest Quarter of the Northeast Quarter of Section 36, Township 4 North, Range 7 ½ East, Willamette Meridian, being 15 feet on each side of the following described centerline.

BEGINNING at a point lying North 01°08'05" East 46.17 feet from the Southwest corner of said North Half of the Southwest Quarter of the Northeast Quarter which point is on the shoulder of Panther Creek Road; thence South 88°14'20" East 198.72 feet to the center of an intermittent stream; thence South 82°33'35" East 101.66 feet; thence South 63°35'49" East 81.00 feet to a point on the South line of said North Half of the Southwest Quarter of the Northeast Quarter (from the Southwest corner thereof lies North 98°35'49" West 373.00 feet), and there terminating.
