WATER STORAGE FACILITY EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, KATHRYN IRENE AYA, Successor Trustee under the RODERICK HONEYMAN AYA LIVING TRUST, dated April 17, 1993, a revocable living trust and any amendments thereto, hereinafter called grantor, for One dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby grant and convey unto The State of Washington, Parks and Recreation Commission, hereinafter called grantee, and to its successors and assigns, subject to valid existing easements and rights, a perpetual, non-exclusive easement for an existing water storage facility upon the lands of the grantor in Section 24, Township 2 North, Range 6 East, Willamette Meridian, in the County of Skamania and the State of Washington, more particularly described as follows:

Beginning at the southwest comer of Section 24, Township 2 North, Range 6 East, Willamette Meridian, Skamania County, Washington, monumented with a Skamania County Brass Cap; thence North 25 feet along the west line of said Section 24 to the TRUE POINT OF BEGINNING; thence easterly, parallel with the south line of said section, 50 feet; thence nurtherly, parallel with the west line of said section, 100 feet; thence westerly, parallel with the south line of said section, 50 feet to the west line of said Section 24; thence southerly along said west line of said Section 24, 100 feet to the TRUE POINT OF BEGINNING. This easement area contains a concrete water storage facility and is 0.11 acres, more or less.

The location of said water storage facility easement is generally depicted on the attached Exhibit A-2 which by this reference is made a part hereof.

This non-exclusive easement shall allow the grantee to enter upon said lands and to repair, reconstruct, operate and maintain the existing water storage facility and associated equipment for use by the Beacon Rock State Park campground. This non-exclusive easement shall also allow the grantee to cut and trim trees and shrubbery upon said lands that may interfere with or threaten to endanger the safe operation and maintenance of said facility. This easement shall not allow the grantee to construct any new improvements nor expand the size of the existing facility.

It is agreed that the existing facility, as installed on the above-described lands, shall remain the property of the grantee and shall be removable at the option of the grantee. It is further agreed that the grantor, and her successors and assigns, shall not be liable for any costs whatsoever associated with the reconstruction, repair, operation or maintenance of said facility or any associated improvements and equipment. Any rights and privileges not expressly conveyed hereby remain with the grantor.

TO HAVE AND TO HOLD unto the State of Washington, Parks and Recreation Commission, and to its successors and assigns, the easements rights hereby granted.


