ACTION AS A RESULT OF VACATION PROCEEDINGS
AND PUBLIC HEARING ON NOVEMBER 28, 1994

BOARD OF COUNTY COMMISSIONERS
SKAMANIA COUNTY
STEVENSON, WASHINGTON

WHEREAS Resolution 829-A, dated 24 October, 1994, did declare the intent to vacate certain rights-of-way in the townsite of Cooke, and did direct the County Engineer to report on those roads as required by Chapter 36.87.040, R.C.W., and

WHEREAS the Board did receive the Engineer's Report on said vacation and did call for a public hearing on this matter to be held on 28 November, 1994, and

WHEREAS the Board did ask for additional information and recommendations from the County Engineer, and

WHEREAS that requested information has been received from the County Engineer, and

WHEREAS the Board of County Commissioners have determined that the public would be benefitted by the vacation of certain rights-of-way,

IT IS THEREFORE ORDERED BY THE BOARD OF COUNTY COMMISSIONERS that

- (1) those portions of rights-of-way shown on the attached map, labeled as Exhibit "A" be vacated,
- (2) that a portion of THIRD STREET be retained on the county roles, to become an extension of JACKSON ROAD,
- (3) that JACKSON ROAD's official road logs be changed to include the portion of THIRD STREET and the newly constructed cul-de-sac,
- (4) that a utilities easement be retained for the existing water lines using existing rights-of-way,

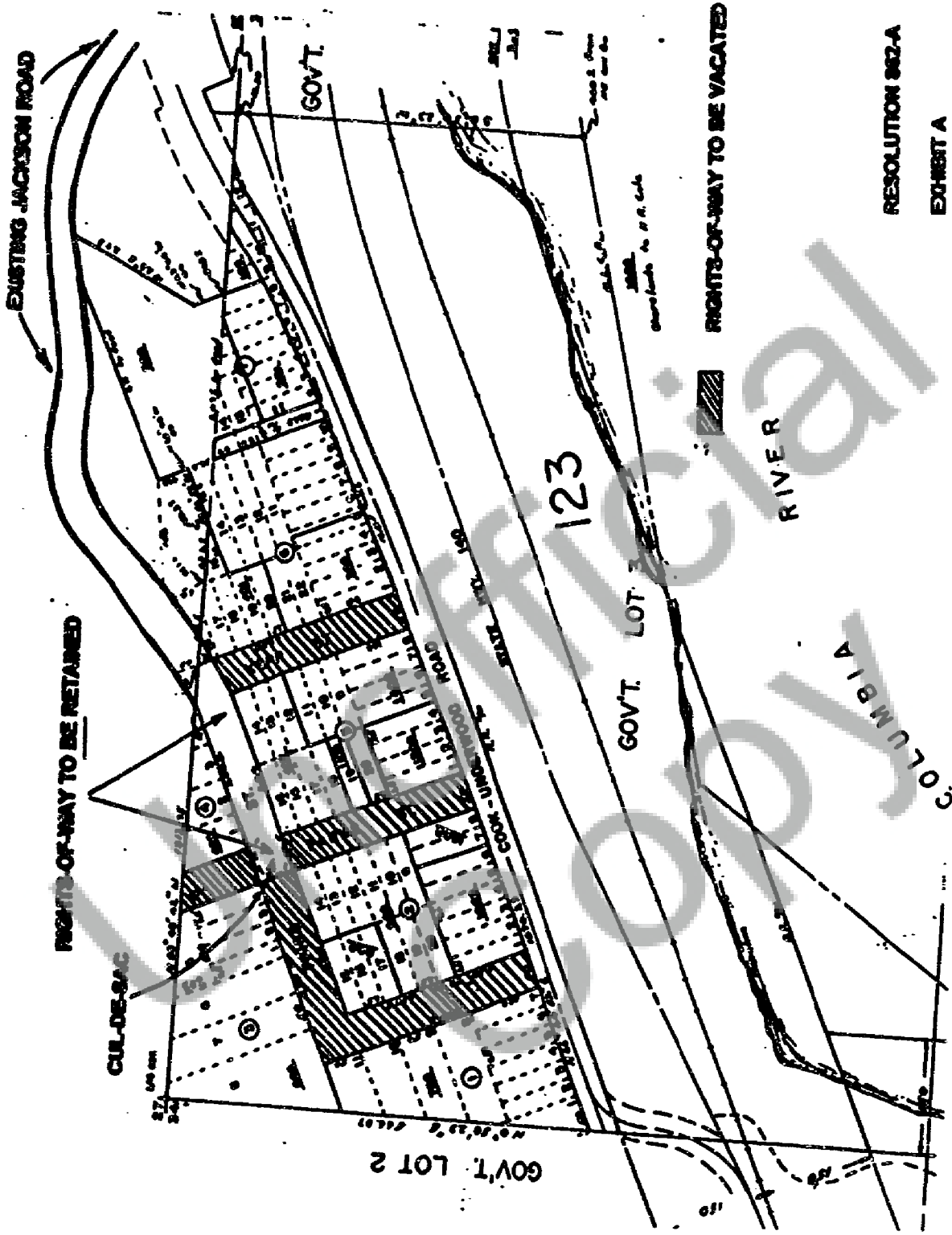
