

PARCEL 4:


A portion of the Northwest quarter of Section 29, Township 3 North, Range 5 East, Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at the Southwest corner of the Northwest quarter of Section 29; thence North $00^{\circ} 22' 10''$ East, along the West line of said Northwest quarter, for a distance of 1080.00 feet to the TRUE POINT OF BEGINNING; thence North $89^{\circ} 42' 21''$ East, 2625.73 feet to the East line of said Northwest quarter at a point that bears North $00^{\circ} 38' 43''$ West, 1080.00 feet from the Southeast corner of said Northwest quarter; thence North $00^{\circ} 38' 43''$ West, along said East line, 360.00 feet; thence South $89^{\circ} 42' 20''$ West, 2619.35 feet to the West line of said Northwest quarter; thence South $00^{\circ} 22' 10''$ West, along said West line, 360.00 feet to the TRUE POINT OF BEGINNING.


