PROVISIONS

All conditions and requirements contained in reports of examination or permits previously issued apply to this certificate unless specifically noted below.

"This certificate authorizes the use of water to supply domestic needs and to provide limited outside watering of landscaping. This certificate will be subject to the minimum flows set for Trout Creek as follows: When the flow of Trout Creek falls below the minimums, in-house use for domestic supply will only be authorized. The minimum flow of Trout Creek, downstream from the dam shall be established at the following schedule:

- December through June – 25 cubic feet per second
- July through September – Minimum flow of Trout Creek as measured at the upstream gauge is 8 cfs. Flows in excess of 8 cfs may be stored in the reservoir.
- October through November – 10 cubic feet per second.

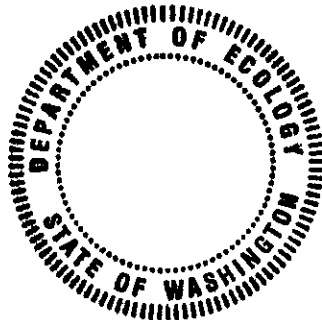
The intake shall be screened at all times in accordance with Department of Fish and Wildlife screening criteria. This water right is issued subject to Washington Department of Fish and Wildlife Hydraulic Project Approval.

The Water Resources Act of 1971 specifies certain criteria regarding utilization and management of the waters of the state in the best public interest. Use of water may be subject to regulation at certain times, based on the necessity to maintain water quantities sufficient for preservation of the natural environment.

The right to use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described, except as provided in RCW 90.03.380, 90.03.390, and 90.44.100.

This certificate of water right is specifically subject to relinquishment for non-use of water as provided in Chapter 90.14 RCW.
